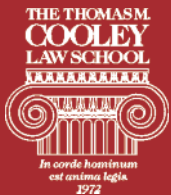

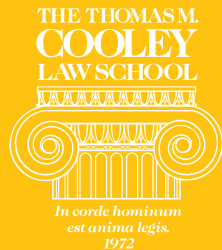
BEFORE JOINING THE COOLEY FULL-TIME FACULTY
